| 1  | <p><b>How does the school know if children need extra help?</b></p> <p><b>What should I do if I think my child may have special educational needs?</b></p> | <p>At Riverview we:</p> <ul style="list-style-type: none"><li>• Track the progress of all pupils and all staff regularly and discuss any concerns we have as well as celebrate achievement.</li><li>• Use data and other forms of assessment to identify additional needs.</li><li>• Encourage parents/carers to speak to the class teacher and/or the Special Educational Needs coordinator (SENCO) and/or the Headteacher about any concerns they have.</li><li>• Work closely with other professionals.</li></ul>   |
| 2. | <p><b>How will school staff support my child?</b></p>  | <p>We are a mainstream, inclusive school that fully complies with the requirements outlined in the Special Educational Needs Code of Practice (2014). Staff have been trained so as to be able to meet the needs of learners who may have difficulties with:</p> <ul style="list-style-type: none"><li>▪ Cognition and Learning</li><li>▪ Communication and Interaction</li><li>▪ Social, Emotional and Mental Health</li><li>▪ Sensory and/or Physical</li></ul> <p>We make reasonable adjustments to our practices so as to comply with the Equality Act (2010). |   |   | <ul style="list-style-type: none"> <li>• Attachment</li> <li>• ASD</li> <li>• Specific learning difficulties</li> <li>•</li> </ul> <p>Having identified needs, we seek to match provision to need for all pupils.</p> <ul style="list-style-type: none"> <li>• We monitor the impact of interventions through regular meetings and tracking of pupil progress.</li> <li>• We monitor your child throughout the day to ensure that we are supporting their needs.</li> <li>• Weekly team meetings are held where our informal monitoring and observations of children are shared with staff, ensuring that your child is supported throughout the school day.</li> <li>• Praise is used for celebrating achievements and effort in learning by all members of our team.</li> </ul>   |
| 3 | <p><b>How will the curriculum be matched to my child's needs?</b></p>   | <ul style="list-style-type: none"> <li>• On-going assessment is used to ensure that daily planning meets the needs of all pupils.</li> <li>• Regular Pupil Progress Meetings help us to monitor individual progress and identify the next best steps.</li> <li>• Half- termly meetings are held with the SENCO to discuss how the curriculum can support the needs of all children.</li> <li>• All our teachers are clear on the expectations of quality first teaching and this is monitored regularly by the leadership team.</li> <li>• Effective planning with clear learning objectives and steps to success ensure that all children can access the learning.</li> <li>• Use of displays and resources are used well to support all aspects of the curriculum.</li> <li>• Children are involved in all aspects of their learning from selecting their topics to working collaboratively.</li> <li>• Talk partners are used to help children discuss their learning and help each other with ideas.</li> </ul> |
| 4 | <p><b>How will both you and I know how my child is doing and how will you help me to support my child's learning?</b></p> | <ul style="list-style-type: none"> <li>• Learner feedback is part of our established learning culture. This includes informing families of next steps and what they can do to help/support their child's learning on a termly basis.</li> <li>• Throughout the year there are opportunities to learn about your child's learning through 'open lessons' and workshops to help families understand what learning is expected and how best you can support your child's needs.</li> <li>• We believe in supporting our parents through the work of our school employed Family Support Worker who delivers individual and group sessions that are tailored to specific needs.</li> </ul>   |

| <b>5</b> | <b>How will my child be consulted and involved in their education?</b>                    | <ul style="list-style-type: none"> <li>• Termly reviews of additional support plans are held with your child and classteacher. Targets are reviewed and new ones chosen for the next term.</li> <li>• One page profiles are created with your child so they can identify their strengths, things that are important to them and how they would like to be supported with their learning.</li> </ul>  |
| <b>6</b> | <b>What support will there be for my child's overall well-being?</b>                      | <ul style="list-style-type: none"> <li>• All our staff are regularly trained to provide a high standard of pastoral support.</li> <li>• Relevant staff are trained to support medical needs and in some cases all staff receive training.</li> <li>• We have a Medical Policy in place.</li> <li>• Our Behaviour Policy; which includes guidance on expectations, rewards and sanctions is fully understood and in place by all staff and reviewed regularly.</li> <li>• We monitor attendance weekly and take the necessary actions to prevent prolonged unauthorised absence.</li> <li>• Pupil voice is central to our ethos and this is encouraged through the work of our school council, and on-going effective communication between adults and pupils.</li> <li>• We have a zero tolerance approach to bullying in the school which addresses the causes of bullying as well as dealing with negative behaviours.</li> <li>• Our PSHE programme also looks to develop emotional and social development.</li> <li>• Our school Family Support worker and ELSA (Emotional Literacy Support Assistant) work with individuals and small groups to develop their emotional and social skills.</li> </ul> |
| <b>7</b> | <b>What specialist services and expertise are available at or accessed by the school?</b> | <ul style="list-style-type: none"> <li>• We hold meetings where professionals from outside the school are invited to attend. During these meetings we may discuss individual cases where it is felt support above and beyond what the school is able to offer is necessary. In these cases parents and young people will be consulted and consent sought so that agencies are able to work together in supporting the overall development of the young person.</li> <li>• Our staff receive regular training and our teachers all hold qualified teacher status.</li> <li>• We have close links with our Children's Centre and the services that they provide for children and families.</li> <li>• We have a number of established relationships with professionals in health including our school nurse, speech and language therapists, paediatricians and links with CAMHS.</li> </ul>   |

|    |  | <ul style="list-style-type: none"> <li>• Advice is sought from Linden Bridge outreach team who support Autistic Spectrum Disorder pupils.</li> <li>• All external partners we work with are vetted in terms of safeguarding.</li> <li>• We have a particular duty in ensuring that Looked After Children are given the appropriate support and care to help support their progress and engagement within the learning environment. Our designated teacher Mrs L. Sales meets with social services and the virtual school to ensure the child's wider needs are being met. A personal education plan (PEP) is produced termly to help support the child develop holistically.</li> </ul> |
| 8  | <b>What training are the staff supporting children with SEND had or are having?</b>              | <ul style="list-style-type: none"> <li>• Our current SENCO has been in post for 23 years and therefore does not qualify for the mandatory National SENCO Award for new SENCOs. However she does hold an MA in Special Education Needs and BA in Education.</li> <li>• We regularly invest time and money in training our staff to improve wave 1 provision delivery.</li> <li>• Support staff are trained to deliver specific interventions in English, Mathematics, social skills, behaviour and language programmes.</li> <li>• Support staff receive specialised training depending on the needs of individuals.</li> </ul>  |
| 9  | <b>How will my child be included in activities outside the classroom including school trips?</b> | <ul style="list-style-type: none"> <li>• Our Inclusion Policy promotes involvement of all learners in all aspects of the curriculum including activities outside the classroom.</li> <li>• Where there are concerns of safety and access, further thought and consideration is put in place to ensure needs are met. We make reasonable adjustments so that learners can join in with activities regardless of their needs.</li> <li>• At least one of our qualified First Aiders accompanies any school trip.</li> <li>• When necessary detailed planning meetings are held with parents and carers to ensure that all pupils can participate in activities and trips.</li> </ul>      |
| 10 | <b>How accessible is the school environment?</b>   | <ul style="list-style-type: none"> <li>• Our Accessibility Plan is robust and we continually remind staff and learners about the Equality Act 2010.</li> <li>• We value and respect diversity in our setting and do our very best to meet the needs of all our learners.</li> <li>• There is full wheelchair access to the ground floor of the building and there is a lift to the first floor.</li> <li>• There are disabled toilets on both floors.</li> </ul>  |

| 11 | <p><b>How will the school prepare and support my child to join the school, or the next stage of education and life?</b></p> | <ul style="list-style-type: none"> <li>• Every family meets with the Headteacher, Mrs M Atkins, for a discussion about their child before they join Riverview.</li> <li>• Key members of staff are informed of any needs or support that a child may need when starting our school.</li> <li>• We have a robust Induction programme in place for welcoming new learners to our setting. Home visits are made to all children entering the nursery and any children who join the school in the reception class. There is a staggered, settling in time which is flexible to meet the needs of all learners.</li> <li>• We have very good relationships with any feeder settings as well as settings children move onto. Staff from the local high schools visit Riverview to meet year 6 pupils before their induction days and discuss with staff any support that a child might need.</li> <li>• Transition programmes are set up for children who may require additional support when moving to different year groups or schools. This is provided by our Family Support Worker.</li> </ul>   |
| 12 | <p><b>How are the school's resources allocated and matched to children's special educational needs?</b></p>                 | <ul style="list-style-type: none"> <li>• The Special Educational Needs (SEN) budget is allocated to provide resources for pupils every financial year. The money is used to provide additional support or resources dependent on an individual's needs. Some of the funding the school receives may go towards funding training so that in-house provision is more targeted at needs</li> <li>• Additional funding for individual pupils may be provided through an Education Health Care plan awarded by the local authority.</li> <li>• The SENCO carries out learning walks which include reviewing how provision is delivered and helps in maintaining standards through rigorous quality assurance.</li> <li>• Our provision management tool also looks at the impact each intervention has had on the Decisions are made as to whether specific interventions are proving to be effective both in terms of the time spent on them and the finance used in providing the intervention.</li> <li>• Each year we review the needs of the whole cohort to see if there is a change in the overall make- up of the school. Decisions are then made as to whether any additional interventions need to be put in</li> <li>• Our finances are monitored regularly and we utilise resources to support the strategic aims of</li> </ul> |

| 13 | <p><b>How is the decision made about what type and how much support my child will receive?</b></p> | <ul style="list-style-type: none"> <li>• Quality First inclusive Practice (wave 1) is clearly defined in our setting and we expect all staff to deliver this.</li> <li>• Should additional support be required, this is undertaken after consultation with the relevant staff and is discussed at regular parent consultation meetings.</li> <li>• All interventions are monitored for impact and outcomes are defined at the start of any intervention.</li> <li>• The SENCO oversees all additional support and regularly shares updates with the SEND Governor.</li> </ul>   |
| 14 | <p><b>How are parents involved in the school?</b></p> <p><b>How can I be involved?</b></p>         | <ul style="list-style-type: none"> <li>• We whole-heartedly believe in partnering with parents to support a child learning, needs and aspiration. We operate an open door policy and take every opportunity to strengthen this dialogue.</li> <li>• Parents are invited to contribute through a number of means including participating in whole school events, involvement with their child's Additional Support Plan, supporting their child at home, volunteering to help in classes and participating in parenting groups.</li> <li>• Our Governing Body includes Parent Governors/representatives.</li> <li>• Becoming a member of the PTA</li> </ul>  |
| 15 | <p><b>Who can I contact for further information?</b></p>   | <ul style="list-style-type: none"> <li>• In the first instance, parents/carers are encouraged to talk to their child's class teacher.</li> <li>• Further information and support can be obtained from the school's SENCO Mrs L. Sales who can be contacted via the school office.</li> <li>• Our Family Support Worker, Hayley Brown</li> <li>• Our Headteacher, Mrs M Atkins</li> <li>• A copy of the school's complaints procedure can be found on the school website (put in link). The complaints procedure will outline the formal steps the school will take in handling each complaint.</li> <li>• Where a resolution between the parent and school cannot be reached then parents will be advised to seek external support through the Parent Working Partnership.</li> </ul> |
